You are asked to keep this agreement in the Vehicle at all times as proof of your right to be in possession of the Vehicle under the 'Terms and Conditions' contained herein. Red Rock cannot and will not be held responsible nor liable for any situations that result from your failure to produce this agreement for examination when requested by legal authority.

## **TERMS AND CONDITIONS**

The Terms and Conditions herein, together with the information on the Rental Agreement, constitute the entire "Agreement" between "you, the Renter/Driver and/or any additional Drivers who's signature" is affixed to this Agreement, and Red Rock Adventure Rentals Inc., here in referred to as "Red Rock," regarding your rental of a "Vehicle" (in its entirety) from Red Rock. By signing these Terms and Conditions & Rental Agreement, you are hereby agreeing to, abide by and be bound by, all of these provisions.

- 1. **GENERAL:** This Agreement will be construed and interpreted according to the Laws of Arizona. This Agreement constitutes the entire agreement between Red Rock and You and it shall be binding upon and inure to the benefit of the parties, their respective heirs, executors, successors or assigns. This Agreement cannot be altered except in writing. Red Rock remedies under this Agreement are not exclusive and its failure to strictly enforce any provisions of this Agreement will not be construed as a waiver of that provision or as excusing You from future performance. Any provision of this Agreement on which is deemed non-enforceable, or is prohibited, will not invalidate the remaining provisions hereof. You hereby agree to subject yourself to the exclusive jurisdiction of the courts of the State of Arizona, in any action or proceeding arising, or related in any way to this Agreement. In no event shall Red Rock be liable to you for any indirect, special or consequential damages related directly or indirectly to any breach by Red Rock of this agreement. You may not sublet the vehicle, nor may you transfer or assign this agreement. You are not an agent of Red Rock for any manner or purpose. No modification may be made to this agreement unless in writing and signed by both parties. You guarantee that the Vehicle will be operated as required by this Agreement. Except for the ordinary wear and tear, you must return the Vehicle in the same condition that You received it to the specified Red Rock location on the return date and time noted; and/or earlier, if requested by Red Rock, and pay all fees and charges due under this Agreement, even if you did not specifically authorize the driver of the Vehicle to incur the charges. You agree to defend, indemnify and hold Red Rock harmless from and against all loss, liability or damages whatsoever, caused by arising out of the maintenance, use or operation of the Vehicle during the rental.
- 2. **OWNERSHIP:** Red Rock is the owner of the Jeep you are renting. By renting it, you are being permitted by Red Rock to use the Jeep under the terms of this agreement. You have no authority to act for or on behalf of Red Rock in any situation. You require no title to the vehicle, and or any component contained on or therein, and no one other than Red Rock may transfer said title.
- 3. **RENTAL REQUIREMENTS**: Any and all renter's and or additional drivers A.) must be 25 years of age. B.) must provide a valid State Issued Driver's License or International Driver's License. C.) must provide to Red Rock prior to picking up the rental vehicle, a VALID certificate/proof of a FULL INSURANCE COVERAGE POLICY in the renter's/driver's name(s). Red Rock will verify any and all insurance policies, as related to any renter/driver(s). D.) must further maintain the verified Insurance Policy provided throughout the entire agreement contract term. E.) must have a valid major credit card with the renter/driver(s) name(s) on it. F.) must be able to provide said credit card at the time of the rental to Red Rock.
- 4. **USE OF THE JEEP:** A.) Rental of this Jeep is limited to fully insured and valid licensed U.S. drivers 25 years or older. Only you, and anyone who has signed these Terms and Conditions/Agreement as an additional driver, are permitted to drive the Jeep. B.) You agree to drive the Jeep only on established roads, thoroughfares or Jeep trails within the State of Arizona; paved or un-paved. You agree not to drive the Jeep on the following areas: Off-road, mudding, and/or rock climbing in non-designated areas. Any vehicle caught in these areas will be charged a minimum penalty of \$250.00. Red Rock reserves the right to electronically track our vehicles at any and all times. C.) You agree to carry no more than the vehicle rated number of occupants in the Jeep. You also agree that all persons will ride in seats within the passenger compartment of the Jeep. Occupants must wear seat belts at all times. Arizona State Law mandates that all children under 8 years old and/or under 4 ft 9 in. must sit in an appropriate child or booster seat. D.) You agree not to place ice chests, coolers, or other large objects which may cause damage to the seats, on any of the seats of the Jeep,. You may place them on the floor or in the cargo area. E.) You agree not to use the Jeep to tow, push, pull or otherwise move any other vehicle, trailer or object. F.) You agree not to use the Jeep in any way that violates local, state, or federal law, including failure to report an accident. If you fail to abide by any of these provisions, you will be solely responsible for any injury or damage that occurs. This may include the full value of the Jeep and any loss of business which Red Rock suffers because of any damage to the Jeep. G.) You agree not to smoke or vape in the Jeep, a \$250.00 fine will be applied if evidence of smoking or vaping is apparent. H.)

You agree to pay a \$50.00 additional fee for pets or animals in the Jeep. I.) You agree to not remove the entire hard top of Jeep, if applicable. ONLY the Freedom Panels may be removed during good weather conditions. You are responsible for the care and condition of the Freedom Panels while they are off the Jeep J.) If you have been instructed at the time of delivery, or shown to have working knowledge of its operation- You may fold the soft top back on the soft top equipped Jeeps. You may remove the Side Windows and Rear Window of the soft top equipped Jeeps. K.) You will be responsible for any damages to any portion of the soft top as a result of improper removal, storage, loss or re-installation.

- 5. **AUTHORIZED DRIVER'S:** The Vehicle must be operated only by an "Authorized Driver" (You). Under this agreement, an Authorized Driver is the person whose signature appears on this agreement as primary renter "Primary Driver" and any additional person who appears at the time of the rental and signs this agreement. An Authorized driver must satisfy the age requirements of Red Rock, have a valid driver's license and fulfill other rental qualifications and fees. By signing this Rental Agreement, You represent that You are capable and a validly licensed driver, 25 years of age or older. The primary renter is primarily liable for all charges related to this agreement. If the primary renter directs a Billing for charges to be transmitted to another person, firm or organization, and such party upon being so billed fails to make payment, primary renter shall promptly pay said charges.
- 6. **VEHICLE CONDITION AND RETURN:** A.) You agree that the Jeep which you have rented is in good condition when rented to you (except as noted on the attached diagram) and that you will return it in good condition without any damage or injury. B.) If you do not return the Jeep on time, or if you violate any provision of this agreement, Red Rock will be permitted to locate and repossess the Jeep without any notice or hearing. If Red Rock repossesses the Jeep, you will pay any costs incurred by Red Rock in doing so. C.) You agree to return the vehicle on the due back date, or upon Red Rock's demand, if sooner. D.) If the vehicle is not returned when due and/ or within 24 hours after written or oral demand by Red Rock, the authorized driver will be therein considered in 'unlawful possession of the vehicle," and Red Rock will seek the warrant for the arrest, of anyone in possession of the vehicle (including authorized driver) and/or seek any other legal remedy at Red Rock's option.
- 7.) **WARRANTY**: You are renting the Jeep 'As Is." Red Rock makes no warranty to you or anyone else of any kind or nature, whether express or implied, as to merchantability or fitness of the Jeep for any particular purpose. Under no circumstances will Red Rock be responsible for any loss, damage or inconvenience which you may suffer as a result of any breakdown or malfunction of the Jeep.
- 8. **RENTAL CHARGES:** Time charges are based on a 24-hour day rental period, starting at the time selected at the time of your booking of the rental. This constitutes a 'Day Rental.' The minimum charge is for said (1) Day rental. A \$55.00/per hour fee will be charged for each or partial hour you are late, with applicable state and local taxes and assessments. The hourly rate shall apply and begin to accrue only when the vehicle is returned (1) hour after the end of your specific rental agreement return time. The hourly rate continues to accrue until the charges equal the (1) Day rate. There will be no refund/credit issued if the Jeep is returned early due to your scheduling/flight/etc and/or on the demand of Red Rock. You agree to pay Red Rock upon demand and without reduction or setoff, the rates and charges indicated, including any and all other amounts which become due under this Agreement. You have been informed that an amount equal or up to the estimated total charges due under this Agreement, will be reserved or set aside by the credit card issuer whose credit card You present in payment of your bills. You hereby consent to such reserve or set aside by the credit card Issuer. All charges are subject to audit. If, upon audit, an error is found, You shall pay the corrected charges, charges, including changing any charge card invoices signed by You, to reflect correct charges, with written or verbal notice of correction to You. You fail to comply with this agreement if the total payment of the amount of the agreement is not satisfied. If you do not make the corresponding payment within the term of ten (10) business days, Red Rock will apply a charge of 5% of the monthly compound balance due. In case of default, Red Rock may claim the total amount due, plus additional charges. I authorize Red Rock to disclose to any credit agency the information concerning my credit experience with Red Rock.
- 9. **COMPUTATION OF CHARGES:** The Renter is responsible in entirety for A.) Time: Computed at the rate set forth on this agreement. B.) the Jeep or any tools, parts, equipment, accessories, or other items which accompanied it when rented to you, whether they are lost or damaged, you will be responsible and strictly liable for the full retail cost of repairing or replacing the lost or damaged items, whether or not, the loss or damage is your fault. C.) Refueling Service Charge: The Vehicle will be delivered with fuel. In the event it is returned with less fuel than when rented, you shall pay a refueling service charge as well as the amount of fuel needed to refill the tank of fuel as per Red Rock's refueling service charge policy. D.) Drop-off charges, if applicable, if Vehicle is not returned to renting location, E.) for other services supplied by Red Rock and for any loss, theft or damage to any accessories or equipment supplied by Red Rock F.) Red Rock's reasonable and verified cost and expenses for repairing Vehicle, if Vehicle was damaged while being used by you during your rental agreement and/or used by you in violation of any of the terms and conditions of this Agreement, including but not limited to: out of service time, loss rentals, attorney fees, recovery and/or other expenses resulting from (i) operation off a paved road, flooded or water filled area or road or any other such reckless or abusive vehicle handling (ii) operation with flat or under inflated tires, insufficient motor oil, coolant or other vehicle fluids, or collision with a low

overpass or other overhead object; (iii) collision with any mobile or stationary object; (iv) vehicle loading, unloading and overloading beyond manufacture's recommended maximum GVW or GCW. G.) any fines, costs, penalties or assessments of any type levied or charged against Red Rock or which Red Rock is obligated to pay and which arise out of your specific rental, use or possession of the Jeep. H.) Red Rock reserves the right to assess damages, including, but not limited to, damages found on the Vehicle returned to Red Rock, within a maximum of 24 hours from the time of the return. I.) You/the Renter, here by agree that Red Rock may charge your Credit Card on file for any and all such charges that may arise during and/or as a result of your specific rental. J.) you here by agree not to file any disputes with the issuing credit card bank, as it relates to your rental and or any fee incurred to you as outlined in this Agreement, as a direct result of your specific rental overall. K.) Any chargebacks issued to a renter's credit card after the rental has been completed and/or the rental vehicle has been inspected and audited will be held to the terms herein and subsequently subject to a \$250.00 administrative service fee, no matter what the resolution. L.) A copy of this Rental Agreement in its entirety shall be submitted to the cardholders bank in any case related to a dispute initiated by the renter/driver(s). Please note any rate or fee is subject to change at any time without notice.

- 10. **FUEL, CLEANING and/or TOWING CHARGES:** A.) Fuel: When you return the Jeep, it must have a full tank of unleaded regular gasoline or you will be charged for refueling. The charge for refueling will be at current market rate plus \$2/gallon, as well as a service fee of \$40.00 will be applied. B.) Cleaning: Any Jeep returned with excessive mud, dirt or road debris will be charged a minimum \$100.00 excessive cleaning fee. If the vehicle has been found to have been 'smoked' or 'vaped' in, a minimum \$250.00 cleaning/detailing fee shall be applied. D.) Towing: If the Jeep must be towed for any reason, not excluding any mechanical breakdown, or if Red Rock has to pay any costs associated with recovering the Jeep, you will pay those costs and will reimburse Red Rock for any loss due to downtime of the Jeep.
- 11. DAMAGE OR LOSS: It is your responsibility to verify that the vehicle is undamaged, prior to departure from Red Rock premises. No claim of prior damage will be accepted unless such damage is indicated at the start of the rental and noted on this agreement. You are absolutely liable for any loss or damage to the vehicle even if someone else caused it or the cause is vandalism or any other cause whatsoever, subject to limitations imposed by the laws of Arizona. Red Rock reserves the right to assess damages, including, but not limited to, damages found on the Vehicle returned to Red Rock, within a maximum of 24 hours from the time of the return. Your liability will not exceed the full value of the vehicle; actual towing and storage costs, loss of use and administrative charges as allowed by law, if applicable, will be charged to your credit card for any damage or loss caused to the vehicle. It is your responsibility to make a claim with your insurance company or credit card company for the appropriate reimbursement, if applicable. Red Rock is not responsible for loss of time, expenses, or any other incurred by you due to mechanical breakdown, accident, or other causes, whether or not said loss or damage was caused or related to the negligence of Red Rock, its agents or employees. You will be provided with one (1) set of keys that are to be surrendered upon demand. You are responsible for the replacement and programming cost of broken or lost keys \$450.00/key. You hereby assume all risk of such loss or damage. Renter assumes all liability for all tire damage due to negligence of the driver(nail in tire, punctured tire, accident causing tire damage, etc.). If the tire requires replacement, the renter is responsible for the cost of the replacement unless renter has purchased the Tire and Glass Coverage.
- 12. **Minor Damages:** Simple Accidents do happen, and are even more likely out on the un-paved established trails/passes. If the Jeep incurs any minor damages at any point while being operated by the renter, most cases can be settled immediately without involving insurance. Listed below are prices you may expect to pay for these minor damages:
  - Fender Flare \$150/corner
  - Bumpers-Scratches-\$50-100/per
  - Bumpers-Replacement- \$550/per
  - Side Rails-Scratches-\$50-100/side
  - Side Rails-Replacement- \$450/set
  - Shock \$150/corner
  - Windshield \$350 \*w/o T&G Coverage
  - Tire \$350/per tire \*w/o T&G Coverage
  - Wheel/Rim- \$350/per wheel
  - Soft Top Rear or Side Window- \$150
  - Soft Top- Total Replacement- \$2,500
- 13. **SERVICE AND REPAIR:** Under no circumstances are you permitted to have the Jeep serviced or repaired without Red Rock's express permission. You will not repair the Vehicle without the consent of Red Rock and you agree that you must have prior approval from Red Rock to purchase any part or accessory in order to relieve reimbursement. You agree to stop driving the Vehicle

should the dashboard warning lights become illuminated during the rental and You agree to inform Red Rock of the problem as soon as possible. When requested by Red Rock for periodic inspections and maintenance, or whenever repairs are needed, You will, at Your expense, deliver the Vehicle to the service facilities designated by Red Rock. The Vehicle will not be operated after a collision or mechanical failure if continued operation of the same would be unsafe or further damage the Vehicle. In such cases, You will notify Red Rock immediately and follow Red Rock directions regarding emergency repair service.

- 14. **LIABILITY:** While Red Rock maintains liability insurance covering the Jeep, which you are renting, your insurance coverage will be primary in the event of any claim. Only after your coverage is exhausted will our insurance make any payments. You agree to indemnify and hold Red Rock, its owners, agents and employees harmless from and against any and all loss, liability or expense in excess of, or outside the scope or extent of, the coverage provided by Red Rock Liability Insurance. In the event that your coverage is exhausted, and our insurance coverage is required to pay, you will be responsible for any deductible. Red Rock provides liability insurance coverage with limits of coverage at or above the minimum levels required by Arizona law. This coverage does not include "uninsured or underinsured motorists" coverage. You and Red Rock, hereby agree to reject any such "uninsured motorist" coverage. In the event any coverage beyond that already provided is required by Red Rock under Arizona law, you agree that the coverage will be the minimum allowed. A renter may be held responsible for all damages, including loss of use, should the vehicle be damaged in an accident, stolen or vandalized. This is the case regardless of fault. Regardless of who is at fault, the renter may be asked to pay for the damage up to and including the total cost of replacing the vehicle in case of a total wreck or loss.
- 15. **OPTIONAL TIRE AND GLASS COVERAGE:** The Tire and Glass Coverage offered by Red Rock is a supplemental policy to help offset the cost of some of the most common damage realized during a rental period-punctured tires and cracker or broken windshields. The coverage allows the renter to save money in replacement costs. By purchasing the coverage, the renter is realizing the following benefits. A.) As it relates to TIRE damage [including but not limited to, puncture, tear, excessive wear, gouging], with T&G Coverage, Red Rock agrees to waive the demand for full cost recovery, as the renter shall only responsible for a \$50.00 deductible per tire, in lieu of current full replacement cost per tire. B.) As it relates to GLASS Damage, Red Rock agrees to waive the demand for full cost recovery as the renter shall only be responsible for a \$75.00 deductible for the front windshield, \$50.00 for each primary door glass, \$75.00 for each rear stationary door glass, \$100.00 for each hard top quarter window and \$150.00 for the rear hard top back glass; in lieu of current full replacement cost per glass/window. C.) As it relates to Soft Top window damage, Red Rock agrees to waive the demand for full replacement cost recovery as the renter shall only be responsible for a \$50.00 deductible for each rear side window or back window.
- 16. **PERSONAL PROPERTY:** Regardless of fault, Red Rock is not liable, under any circumstance, for any loss or damage to your personal property while it is located in the Jeep or at any other time, in any other vehicle, or on any Red Rock premises; regardless of the cause of such loss or damage. In the event your property is lost or damaged, you agree not to make any claim against Red Rock, its agents, employees or owners for the loss or damage.
- 17. **ACCIDENTS or STOLEN JEEP:** If there is an incident involving the Jeep, you must report it immediately to the police and to Red Rock. You agree to cooperate with the police and Red Rock in completing any accident or other reports and will provide the police and Red Rock any information they request in connection with any accident. This includes witness names, addresses and telephone numbers, witness statements, copies of any citations and all other information. Whether or not the loss or theft is your fault, you are responsible for paying Red Rock the full amount of any cost of such loss or theft including any downtime Red Rock incurs.
- 18. **TRAFFIC VIOLATIONS and FEES:** Traffic/ Parking/ Towing or other violations are to be paid by renter. Renter must notify Red Rock of any traffic violations tickets. If a traffic violation is not reported and Red Rock becomes aware after the rental has been returned, the renter's credit card will be charged the traffic violation fee, plus any additional court and service charge fees. It is a state law to show proof of insurance coverage if you are stopped by the police. To avoid an inconvenience during your vacation we ask for proof of coverage ahead of time to keep on file and we recommend that you keep a copy with you. You will pay for all legal charges including parking and traffic fines, penalties, cost and expenses assessed against or paid by Red Rock as well as, a handling fee of \$50.00 for each violation processed by Red Rock. Red Rock Is authorized to realize to any court or governmental agency information relating to your use of the vehicle.
- 19. **PROHIBITED USES OF THE VEHICLE:** The vehicle may not be used: (1) To carry persons or property for hire; (2) To push or tow anything; in a race or similar contest; (3) for any illegal purpose or in the act of a crime, that could be charged as a felony; (4) While a driver is under the influence of alcohol or drugs or driving in a state of drowsiness; (5) Outside Arizona State without prior written consent from Red Rock; (6) To cause damage to the vehicle by intentional, willful, reckless or wanton misconduct; (7) By anyone other than the authorized driver(s); (8) if obtained by fraud or misrepresentation. For purposes of this agreement, willful, reckless or wanton misconduct includes, but not limited to: a. To use the vehicle on other than regularly maintained roadways, private driveways or parking lots, without Red Rock's written permission. b. If any goods or personal property are hauled on the roof of your

truck lid of the vehicle with the use of equipment which either (i) is not compatible with the vehicle, or (ii) was not made by the vehicles manufacturer, (iii) was not provided to you by Red Rock at the time of the rental. c. Vehicles are to be used only for transporting people, no hauling of cargo. d. If any game or wildlife is hauled on the roof or truck lid of the vehicle; or If the vehicle is used to transport animals without prior consent from Red Rock. If any person stands, sits, jumps or walks on either the roof, hood, fenders, bumpers, or trunk lid of the vehicle; or the vehicle is improperly fueled. f. If the vehicle is improperly loaded or used to transport weight exceeding the vehicles maximum capacity, or used to carry hazardous or explosive substances. g. If the vehicle is used to transport passengers and occupants in excess of the number of seat belts in the vehicle or in the bed of the cargo area of the vehicle, or if you do not require all passengers or occupants to comply with seat belts and child restraint laws. h. If the vehicle is used to transport firearms illegally. i. If the integrity of the vehicle is changed or modified in any way including but not limited to the removal of seats or swapping out of tires, regardless of weather damage or loss of value to the vehicle or injury to anyone occurs as the result of such change. \*\*Any prohibited use of the vehicle violates the agreement and voids or deprives you of benefits, protection and optional coverage, if any, to which you would have otherwise been entitled under this agreement. Furthermore, negligence which results in the theft or destruction of the vehicle (failure to safeguard the keys or to lock it) will also result in the voiding of any optional coverage and leave you with the responsibility for the full value of the vehicle.

- 20. **OTHER TERMS**: A.) If there is any dispute between you and Red Rock regarding these Terms and Conditions or the Rental Agreement or which in any way relates to your rental of a Jeep from Red Rock, any suit regarding such dispute must be brought in the courts of Arizona. B.) You agree to submit to the jurisdiction of the courts of Arizona. Any such suit will be decided under the law of Arizona. C.) In the event any part of this contract is illegal or unable to be enforced, the remainder shall remain in effect. D.) If the rental agreement is broken, the vehicle is returned early or confiscated due to the renter not following the terms and conditions, the renter is still responsible for the entire cost of the rental vehicle. E.) The Jeep must be closed and locked when unattended. F.) Windows must be closed for security and to prevent rain damage to the vehicle interior. G.) Renter assumes the liability for all damage due to the negligence of the driver H.) In the event that the vehicle becomes unavailable or requires a repair, Red Rock reserves the right to upgrade, change or cancel the reservation, or book a vehicle elsewhere on the renter's behalf. I.) If roadside assistance is needed and provided directly by Red Rock, the renter will be charged \$95.00 per hour for the road assistance and additionally for any and all related parts, including travel time for an issue(s) due to guest negligence. Available on paved roads only.
- 21. **DEFAULT:** Red Rock may without further notice, demand or hearing, all of which are hereby waived, take possession of, and remove a rented Vehicle wherever it may be found. Whenever You do not return the Vehicle at the date and time established or otherwise violate this Agreement, Red Rock will be entitled to recover all costs associated with such repossession, including reasonable outside legal fees, together with all losses and damages directly or indirectly resulting from any violation of this Agreement by You. Additionally, Red Rock may recover all costs and expenses reasonably incurred in protecting its rights under this Agreement, including reasonable outside legal fees.
- 22. **POWER OF ATTORNEY RENTER/DRIVER(S)**: hereby grants and appoints to RED ROCK ADVENTURE RENTALS INC, a Limed Power of Attorney to present insurance claims for property damage to RENTER/DRIVER(S) insurance carrier if the rented vehicle is damaged during the term of this rental agreement; and to endorse RENTER/DRIVER(S) name on insurance payments for charges or damages.
- 23. **CANCELLATION POLICY:** Cancellations must be submitted 72 hours prior to pickup time, there will be no charge for this. Cancellations made within 72 hours are subject to a one day rental charge at our regular rates. If cancellation is made within 24 hours on a standard rental, a one day rental charge plus a cancellation fee of \$90.00 will apply. In regards to a Camper Jeep and/or long term Jeep rental, the minimum rental fee plus a cancellation fee of \$90.00 will apply. If customer does not show up to rent the vehicle or if cancellation is made post pick up time, the customer must pay for the full rental period at our regular rental rates as per reservation. Any early returns may be a subject to a full charge as per reservation or at our regular rates. Red Rock reserves the right to review, adjust and/or eliminate any cancellation fee at any time.
- 24.) **SHUTTLE SERVICE:** The shuttle service to and from Phoenix Sky Harbor Airport is strictly a courtesy shuttle service offered by Red Rock. It is by no means a guaranteed 24 hour service. Red Rock reserves the right to decline or refuse a shuttle service, based on time, availability, weather, mechanical or any other event or cause, that is not in the best interest of Red Rock and/or may jeopardize the safety of staff members, or the renter/drivers on any Agreement with Red Rock. Applicable notice will be given to renter/drivers if a shuttle service is not available at any time, as it relates to their specific agreement period. Red Rock is by no means responsible nor liable for delays or resulting affects from said delays, in transport to or from the airport, of any nature as a result of weather, traffic, mechanical issues or otherwise unforeseen circumstances or for any other reason not mentioned above, herein determined to be in the best interest of Red Rock.
